On January 19, 2021, the University of Alabama at Birmingham (UAB) acknowledged receipt of supplemental funding under CRRSAA. Furthermore, UAB intends to disburse to students the same amount in emergency financial aid grants as was required under its original Coronavirus Aid, Relief and Economic Security Act (CARES Act) Student Aid Portion award.

2. The total amount of funds that the institution will receive or has received from the Department pursuant to the institution's Certification and Agreement for Emergency Financial Aid Grants to Students under the CRRSAA (a)(1) programs.

The University has received a total of \$21,049,077.00 of which \$6,065,628.00 will be issued directly to students for Emergency Financial Aid Grants.

3. The total amount of Emergency Financial Aid Grants distributed to students under the CRRSAA (a)(1) programs as of the date of submission (*i.e.*, as of the initial report and every calendar quarter thereafter).

As of June 30, 2021, the total amount of Emergency Financial Aid Grants distributed to students is \$5,566,334.00.

4. The estimated total number of students at the institution that are eligible to receive Emergency Financial Aid Grants to Students under the CRRSAA (a)(1) programs.

UAB has 18,528 students that are eligible to receive funds under guidance provided by the Department of Education.

5. The total number of students who have received an Emergency Financial Aid Grant to students under the CRRSAA (a)(1) programs.

As of June 30, 2021, a total of 9,077 students have received funds under this award.

6. The method(s) used by the institution to determine which students receive Emergency Financial Aid Grants and how much they would receive under the CRRSAA (a)(1) programs.

Consistent with Department of Education guidelines, all degree-seeking students enrolled at least half time were eligible to apply for HEERF II funds, with the exception of nonresident aliens. UAB prioritized undergraduate students whose need could be determined by the FAFSA and had an Expected Family Contribution (EFC) below 20,000. This group also included students who were unable to cover an outstanding balance from fall 2020 or spring 2021. HEERF II disbursement amounts ranged from \$500 -\$1,500.
